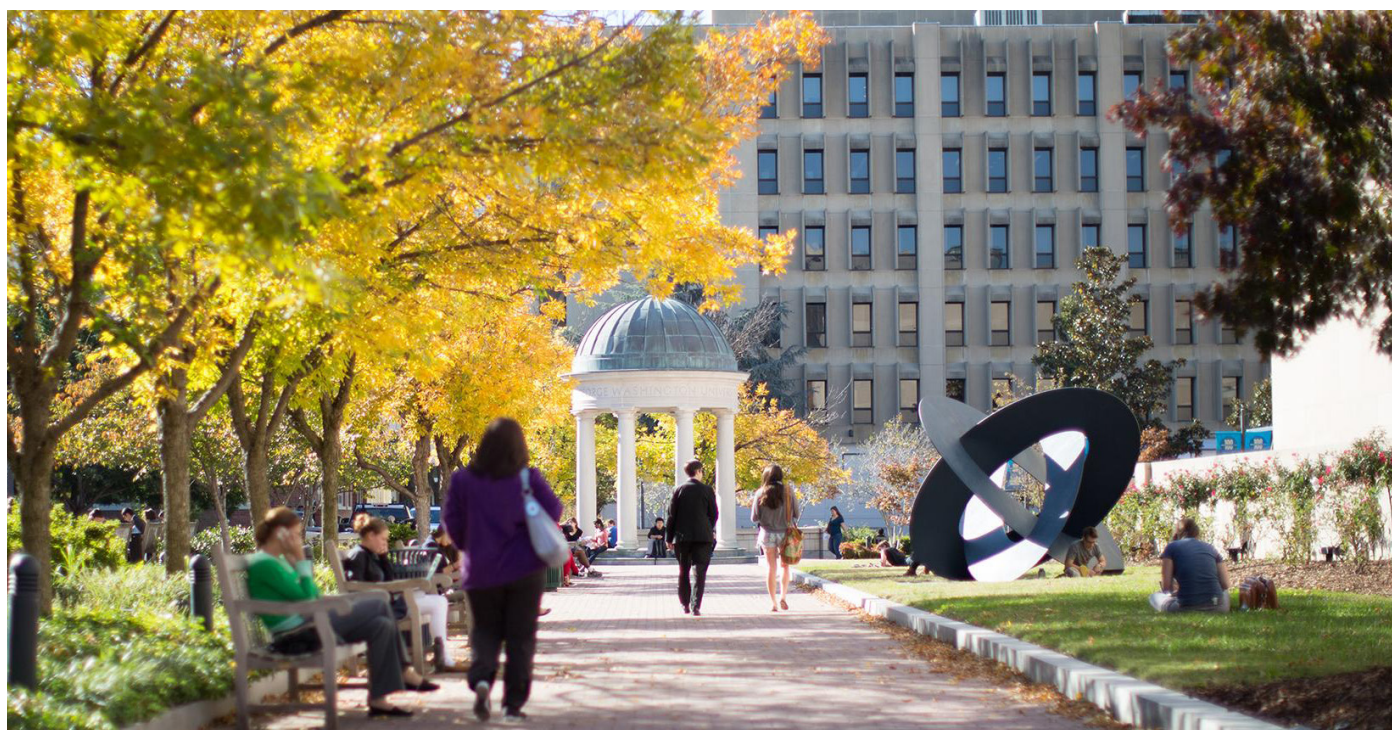

MS in Marketing	<p>Applicants must have a Bachelor's degree from NCU and meet entrance requirements.</p> <p>It is preferred for applicants to have some background in two basic areas—Financial Analysis and Statistics.</p>
MS in Project Management	<p>Applicants must have a Bachelor's degree from NCU and meet entrance requirements.</p> <p>Applicants must also have demonstrated professional interest in project management.</p>

- Tuition Fees at George Washington School of Business (GWSB): **\$67,815***

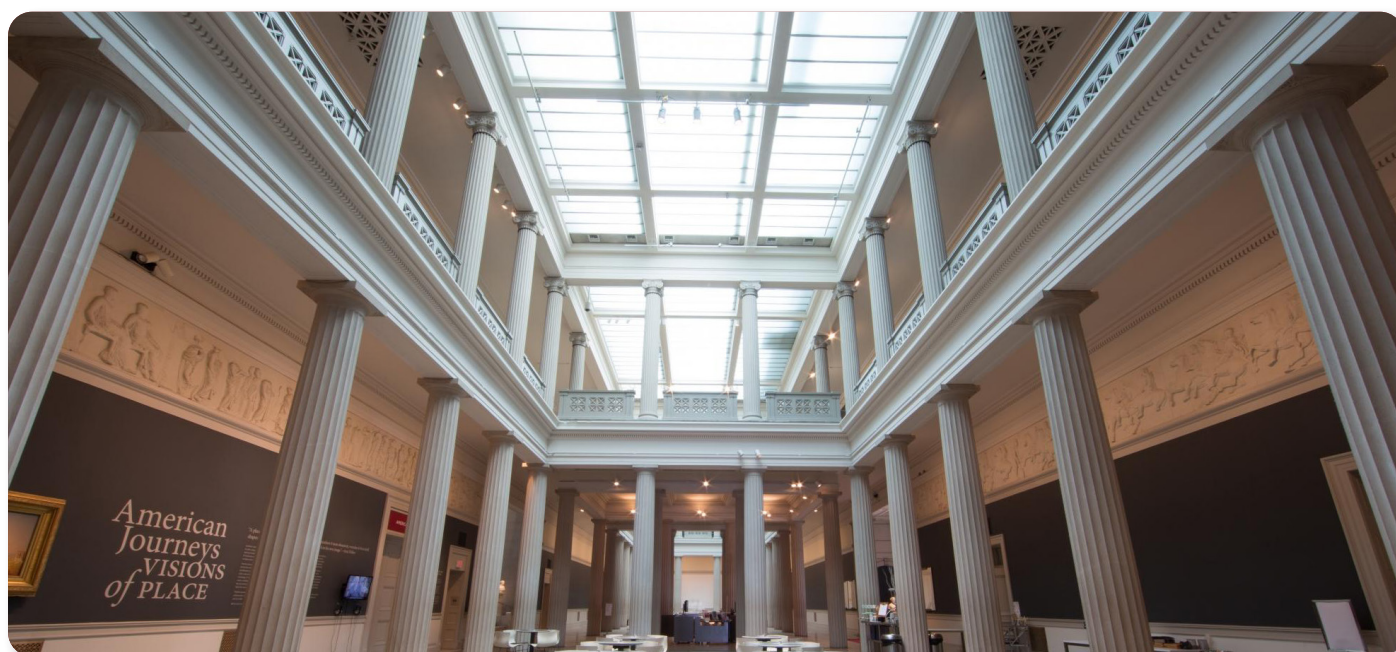
▶▶ Application Deadlines
