

#### 2. Issues under discussion / Elaboration:-

- a. Welcome-The member Secretary welcomed the chairman and all members present and invited the chairman to commence the meeting with his opening remarks.
- b. Opening Remarks of Chairman The vice Chancellor Prof. H.B Raghavendra expressed his satisfaction over the robust measures under taken in the University against ragging and invited petrification of all members towards improving the system and processes further.
- c. Presentation on Anti Ragging The member secretary narrated the gory deaths Pon Navaru and Aman Kachroo which led to the establishment of high level committee under chairmanship of Ex CBI Director Dr. R K Raghwan. This resulted in institution of national helpline against Ragging. Inclusion of Ragging as a crime in Indian Panel Code and issuance of guidelines against Ragging. The definition of Ragging and what all is included in regulations against Ragging and penal outcomes were included in the presentation. He also briefed in detail on the measures undertaken at the NorthCap University that helped in maintenance of the Campus as Ragging free. The measures elaborated are:
  - i. <u>Declaration</u> The NorthCap University is a No Ragging Campus and Same is displayed on notice Boards, Posters, Students Learning Management system, Webpage of University and social media.
  - ii. <u>Anti-ragging Committee</u>- The constitution of committee as per guidelines of UGC and inclusion of all stake holders as members
  - iii. <u>Contact Number-</u> Phone numbers of committee members including local SHO at Palam Vihar Gurugram are displayed at common areas in University Campus.
  - iv. <u>Undertaking</u> An undertaking is obtained from parents and students at the time of admissions towards non indulgence in ragging.
  - v. <u>Letter from Vice Chancellor</u> A letter is sent to all the parents of students exhorting the evil of ragging and the penal outcomes.
  - vi. <u>Freshers Orientation-</u> During initial orientation of freshers programme the advisory on anti ragging is included in the formal briefing by the Registrar.
  - vii. Anti Ragging Squads To cover the entire landscape of the Campus anti ragging squads are constituted which submit their weekly report to the member secretary.
  - viii. <u>CC TV Cameras The academic area and prominent places are covered with CCTV Cameras that act as a deterrent to any kind of indiscipline.</u>
- 3. On conclusion of the briefing by Member secretary suggestion towards improvement were invited from members.

#### 4. Suggestions/ Comments.

- (a) <u>Dr. Hukum Singh</u> He suggested that there is a need to be vigilant against youth who are not enrolled in the University and indulging in to ragging in vicinity of the premises of the University.
- (b) <u>Kunal Dhiya</u> The student representative suggested that display of anti-ragging drive be improved in the area of cafeteria by way of conduct of activities like Nukkad Natak etc.

- (c) Mr BR Verma- the representative of local media lauded the efforts and communicated his great satisfaction for measures undertaken to maintain the NorthCap University Camus free from menace of ragging.
- 5. Concluding Remarks of Chairman The Vice Chancellor Prof. H B Raghvendra complimented the member for suggestions of improvement and thanked all members for their active participation. The Suggestion will be implanted by the University through the participation of relevant clubs and societies in spreading awareness and importance of Anti ragging Environment. He requested local police to increase their visibility for a month starting from 22 July 2019 onwards when the new academic session begins. He called upon the students to be forthcoming in reporting any incident and discouraging other students at the stage of ideation of ragging itself. He was sanguine of support from all quarters and lauded efforts of security staff who were found vigilant and visible.
