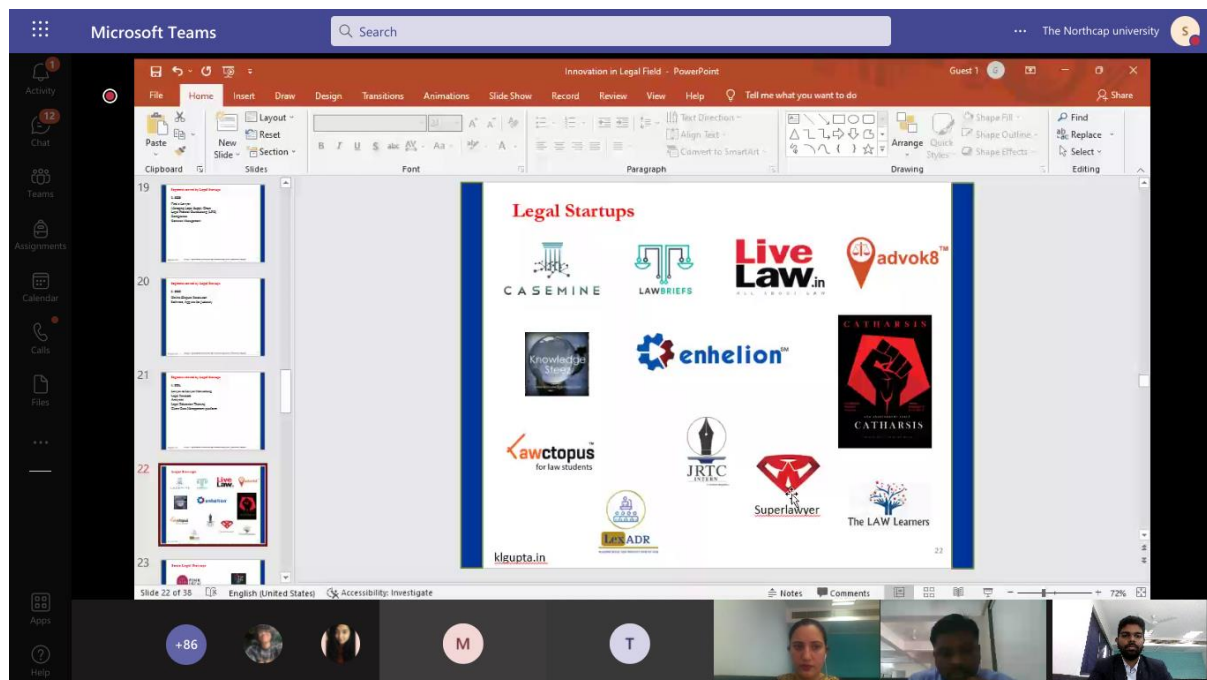
9. Workshop “How to plan for Start-up and legal & Ethical Steps”

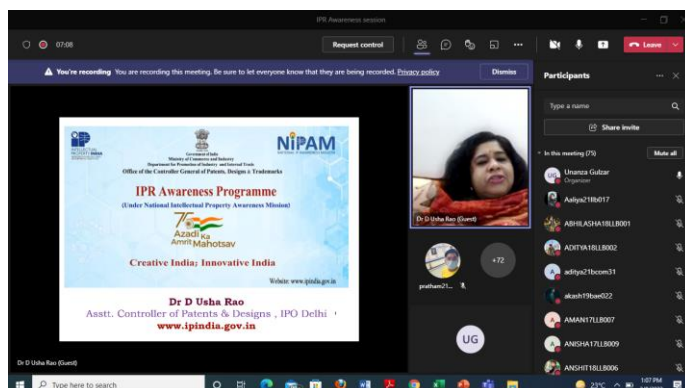
13. Lecture on Issues and Challenges relating to IPR under Cyberspace

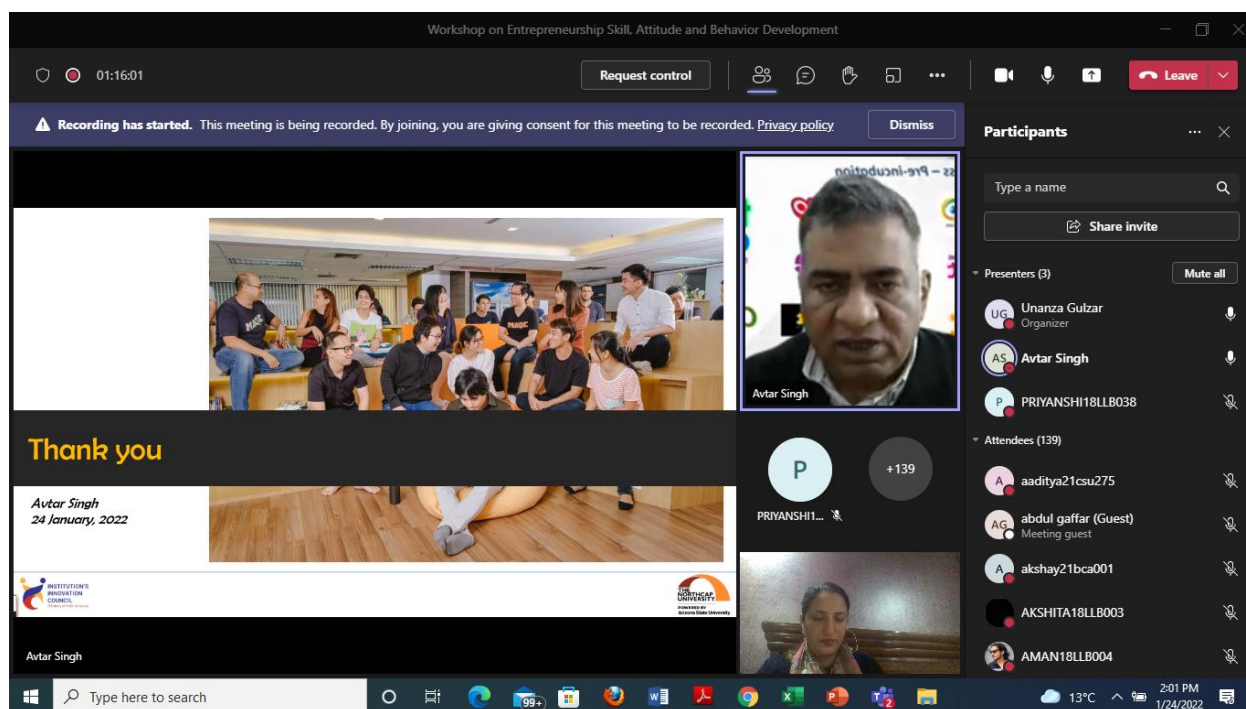
14. Workshop on IPR Awareness
