1. Welcome address by the Chairman

The meeting commenced at 11:00 AM with the Chairperson extending welcome to all members present. The purpose of the meeting was outlined, focusing on academic support and grievance redressal mechanisms for students belonging to reserved categories.

2. Discussion on Academic Support Programs for Reserved Category Students

The members deliberated on the need for strengthening academic support for reserved category students. Key suggestions included:

- Conduct of remedial classes.
- Mentoring by faculty and senior students.

3. Monitoring Grievances and Complaint Redressal

The current grievance redressal mechanism was reviewed. It was noted that there is a need to enhance awareness among students regarding available grievance platforms through faculty mentors / website.

4. Any Other Item with the Permission of the Chair

The Member Secretary brought out that the UGC has issued Guidelines to Provide Equitable Opportunity for the Socio-Economically Disadvantaged Groups (SEDGs) in Higher Educational Institutions" which aim to bridge educational gaps among various social groups,

particularly focusing on historically underrepresented communities such as Scheduled Castes (SCs), Scheduled Tribes (STs), Other Backward Classes

(OBCs), minorities, women, transgender individuals, and persons with disabilities. The Chairman requested the committee members to go through the guidelines available on UGC website and suggest the way forward.
